CONDITIONS

for the «Five Elements of Profit» Special

These Conditions of the "Five Elements of Profit" Special (hereinafter referred to as the Conditions) have been worked out and approved by Gerchik & Co Ltd. (hereinafter referred to as the Company) within the "Five Elements of Profit" Special (hereinafter referred to as the Special) and establish the procedure for participation in the Special, and cover all the persons specified by the Company as participants of the Special (hereinafter referred to as the Participants).

- 1. The Company initiates the Special in order to reward Participants due to the five-year anniversary of the Company by implementing the Company's special offers listed in subclauses (1-5) of clause 3 of these Conditions addressed to the Participants of this Special.
- 2. The Company determines the following period of the Special: from 00:00 am according to the Company's server time on July 27, 2020, to 11:59 pm according to the Company's server time on July 31, 2020 (hereinafter referred to as the "Period of Special").
- 3. The Participants of the Specials shall automatically be the persons who:
